BID FOR: "RESURFACING OF VARIOUS STREETS IN THE CITY OF MOUNT VERNON – 2017 IN ACCORDANCE WITH ATTACHED SPECIFICATIONS"

This proposal will be received by the City Clerk of the City of Mount Vernon, at the City Clerk's office, Room 104, City Hall, One Roosevelt Square, Mount Vernon, New York, until **9:30 AM** on **JULY 28, 2017**, at which time they will be publicly opened and read aloud at a regular meeting of the Board of Estimate and Contract in the Mayor's Conference Room, Rm. 107, City Hall, Mount Vernon, New York.

OBTAINING DOCUMENTS

Plans, Specifications and other applicable Contract Documents may be obtained from the Office of the City Clerk, Room 104, One Roosevelt Square, Mount Vernon, New York, upon a payment of **\$100.00**. The deposit shall be in cash or check payable to the City of Mount Vernon.

The full deposit of each set less the actual cost of reproduction of the plans and specifications, will be refunded upon the return of the entire set of documents in good condition, not later than thirty (30) days following the award of the contract or rejection of bids.

PROPOSAL SUBMISSION

Each proposal must be completed on the forms provided and must be enclosed in a sealed envelope with a description of above title on the outside of the envelope. The name and address of the persons submitting the proposal must appear on the envelope which should be addressed to the Board of Estimate and Contract of the City of Mount Vernon, New York.

Each proposal must be accompanied by:

- a. **A Certified Check or Bank Check** for five (5%) percent of the total amount of the Bid, made payable to the City of Mount Vernon, or Bid Bond for five (5%) percent of the total Bid to be held by the City of Mount Vernon as a guaranty that in the event of the Bid is accepted and a contract awarded to the Bidder, the Contract will be duly executed and its performance properly secured as set out in the Instructions to Bidders.
- b. All Certifications and Affidavits as listed in the **Instructions to Bidders**.
- c. The Aforesaid bid maybe subject to the AFL-CIO Project Labor Agreement (The Building and Construction Trades Council of Westchester and Putnam Counties, New York), also known as the "PLA"

No Bids may be withdrawn for a period of 45 days from the date of opening the proposals.

The City of Mount Vernon reserves the right to reject any and all proposals and to waive any requirements set forth in the specifications which it does not deem material to the proposal, if it deems such waiver(s) in the best interest of the City.
