

AN ORDINANCE AUTHORIZING THE MAYOR
TO ENTER INTO AN INDEPENDENT CONTRACTOR
AGREEMENT WITH SERAPHER CONN-HALEVI

Whereas, by letter dated September 21, 2017, Serapher Conn Halevi has requested legislation authorizing the Mayor to enter into a two-year Independent Contractor Agreement to provide the service of "booting" vehicles, which have outstanding summonses and fines assessed against them; NOW, THEREFORE,

The City of Mount Vernon, in City Council convened, does hereby ordain and enact:

Section 1. The Mayor is hereby authorized to enter into a two-year Independent Contractor Agreement with Serapher Conn-Halevi to provide the service of "booting" vehicles, which have outstanding summonses and fines assessed against them.

Section 2. Under the terms of said agreement, the City will pay said independent contractor the annual sum of \$90,000, in monthly installments of \$7,500.00 for the contract period of November 10, 2017 to November 9, 2019. Further, said Independent Contractor shall have the option to renew said agreement for an additional one-year term at \$94,875.00.

Section 3. Funds for the aforesaid are available in Budget Code A25454

Section 4. This ordinance shall take effect upon its approval by the Board of Estimate and Contract.
