AN ORDINANCE GRANTING PERMISSION TO THE DEPARTMENT OF PUBLIC SAFETY TO ACCEPT FOUR (4) POLICE VEHICLES FROM WESTCHESTER COUNTY POLICE DEPARTMENT.

WHEREAS, by letter dated April 12, 2021, the Commissioner of the Department of Public Safety has requested legislation authorizing permission to lease four (4) vehicles in the amount of One Dollar (\$1.00) per vehicle for a total of Four Dollars (\$4.00) from the Westchester County Police Department; NOW, THEREFORE,

The City of Mount Vernon, in City Council convened, does hereby ordain and enact:

Section 1. Permission is hereby granted to the Department of Public Safety to lease four (4) vehicles in the amount of One Dollar (\$1.00) per vehicle for a total of Four Dollars (\$4.00) from the Westchester County Police Department.


Section 4. This ordinance shall take effect upon its approval by the Board of Estimate & Contract.




