ITEM # 2 PUBLIC HEARING

2.1 Case No. 15 -2013: 403 E Sanford Boulevard (Section 169.33, Block 4069, Lots 25, 29)

The application of Hudson Bank represented by Gary Gianfrancesco, the applicant is proposing to do interior and exterior renovation to the existing building and extend the parking lot.
